# **CERTIFICATION OF INSURANCE**

F1 and J1 students and their dependents must be covered by required medical insurance each semester they are enrolled for classes at MTSU. This time period must include the entire semester calendar date. Forms by applicant's insurance company, which uses the terms: continuous, current, ongoing, etc. as an ending date are not accepted. There must be an ending date stated on the form. First time enrollees must present proof of coverage before their files will be reviewed for admission. Policy requires that for each term after the student's first term, the cost of insurance be added to the student's tuition bill with class registration, if he or she has not shown coverage for that term on a previous form. If the charge is incorrect in any way, please see our office staff immediately.

There are **TWO** ways to meet the insurance requirement.

(1) A student may authorize MTSU to debit his or her account to purchase the Tennessee Board of Regents recommended policy. You may do this by signing the form below.
